Item 2.01 Completion of Acquisition or Disposition of Assets.

On September 1, 2017, Pandora Media, Inc., a Delaware corporation (the "<u>Company</u>") completed its previously announced sale of Ticketfly, LLC, a Delaware limited liability company and wholly owned subsidiary of the Company ("<u>Ticketfly</u>") to Eventbrite, Inc., a Delaware corporation (<u>"Eventbrite</u>") pursuant to the terms of a Membership Interest Purchase Agreement (the "<u>Purchase Agreement</u>") by and among the Company, Eventbrite and Ticketfly, pursuant to which the Company agreed to sell, and Eventbrite agreed to buy, 100% of the issued and outstanding membership interest of Ticketfly from the Company (the "<u>Interests</u>") for an aggregate purchase price of \$200 million, which consists of \$150 million in cash and \$50 million in the form of a convertible subordinated promissory note (the "<u>Note</u>"). The purchase price is subject to customary adjustments for working capital. The Note will be due five years from its issuance date (the "<u>Maturity Date</u>") and will accrue interest at a rate of 6.5% per annum, payable quarterly in cash or stock for the first year, and in cash thereafter. Prior to the Maturity Date, the Note is convertible at the Company's option into shares of Eventbrite's common stock.

The foregoing summary of the Purchase Agreement and the transactions contemplated thereby does not purport to be complete and is subject to, and qualified in its entirety by, the full text of the Purchase Agreement, which was filed as Exhibit 10.5 to the Company's Current Report on Form 8-K filed on June 14, 2017.
