2. 15,984,890 of the reported Common Shares are owned by the following pension plans of Berkshire's subsidiaries: Berkshire Hathaway Consolidated Pension Plan Master Retirement Trust (10,556,408), BNSF Master Retirement Trust (3,308,255), Precision Castparts Corp. Master Trust (1,952,727) and Scott Fetzer Collective Investment Trust (167,500); each of Berkshire, Mr. Buffett and these pension plans disclaims beneficial ownership in such shares.
